For example, the various EU member states use their own standards – such as ZUGFeRD and XRechnung in Germany or FatturaPA in Italy. These international differences make electronic invoicing increasingly complex.

To enable fully automated electronic document exchange and the smooth transfer of large amounts of data, middleware is required that can handle all API and EDI scenarios and thus also has access to Peppol. Peppol (PanEuropean Public Procurement OnLine) is a cross-border network that enables standardised document transfer to all other registered business partners via an access point. This is particularly important for public procurement in the EU, as this is increasingly being handled exclusively via Peppol.

But what can be done if the existing (ERP) system cannot provide the required XML format and does not offer a suitable interface?
